**IMPORTANT ANNOUNCEMENT**

The Board for Local Bodies Accountants Certification (BLoAC) established under ICAI Accounting Research Foundation (ICAI ARF) is pleased to announce that the **Fourth Screening Examination of Certificate Courses for Accountants of Panchayats and Municipal Bodies** will be held on the date and place which are given below:

**1. Date of Screening Examination:**

**3<sup>rd</sup> September 2025 (Wednesday)**

It may be emphasized that there would be no change in the examination schedule in the event of any day of the examination schedule being declared a Public Holiday by the Central Government or any State Government/ Local Bodies.

**2. Eligibility condition to appear in Screening Exam:**

- The candidates who have registered for these courses till 30<sup>th</sup> June 2025 will be eligible to appear in screening exam.
- The candidates who did not clear the previous screening exams or were unable to appear for the exam due to some reason can also apply.

**3. Timing of Screening Examination:**

Screening Examination is of 1.5 hour duration, and the exam timing is mentioned below:

11:30 AM to 1:00 PM	1.5 Hours

**Note:**

- Additional 15 minutes' time will be given to the candidates (from 11:15 AM to 11:30 AM) for reading the question paper before commencement of the exam but the candidates will not be allowed to mark answer/write during this time.
- Screening Examination paper of both courses (i.e., (i) Certificate Course for Accountants of Panchayats, and (ii) Certificate Course for Accountants of Municipal Bodies) would be different.
- There would be one paper of Screening Examination for both level 1 & 2 of Certificate Course for Accountants of Panchayats. Similarly, there will be one paper of Screening Examination for both level 1 & 2 of Certificate Course for Accountants of Municipal Bodies.

#### 4. Places of Screening Examination Centres:

The Screening Examination of Certificate Courses for Accountants of Panchayats and Municipal Bodies will be held in below mentioned 23 Indian cities (provided that sufficient number of candidates offer themselves to appear from each of the below mentioned places). Candidates will have to select their preferred city while filling out the exam form.

#### Note:

- (i) Exam form can be filled only once at prescribed stipulated time frame.
- (ii) The selected exam centre (from the above list) will be allotted to candidates.
- (iii) The details related to the allotted exam centre and address will be printed on the admit card that will be made available on your dashboard one week before the exam.
- (iv) No request for change in examination city will be entertained.
- (v) There is no need to submit hard copy of exam form.
- (vi) Candidates have to bear the expenditure of travel and stay (required to be made if any for appearing in such exam themselves) on their own.

- (vii) The BLoAC reserves the right to withdraw any city/ centre at any stage without assigning any reason.

## 5. Online filling up of examination form

The candidates will be required to login at <https://lba.icaiaf.org.in/> to fill exam form for September 2025 Exam. The exam form will be made available on your dashboard under the tab “Exam”. **The exam form will be available for 15 days, i.e., from 15<sup>th</sup> July till 30<sup>th</sup> July 2025 as mentioned below.**

**Kindly note** Candidates will be required to mandatorily upload photo and choose city of preference for centre of examination.

**There will be no exam fees for first two attempts**, therefore, no separate fee is required to be paid at the time of submitting the exam form. It is to be clarified that the attempt would be counted even if a candidate had filled out the exam form but did not appear for the exam.

**After two attempts, a fee of Rs.118 (Rs 100+ 18% GST) will be charged.**

## 6. Opening and closing of online window for submission of exam form:

- In case of failure of submission of exam form within prescribed time frame, no request will be entertained after last date of submission of exam form.

## 7. QUESTION PAPER BOOKLET LANGUAGE:

Screening exam will be an **OMR based MCQ examination**.

Kindly note that the question paper will be bilingual (in Hindi and English both). The candidates need to submit the question papers along with OMR sheet before leaving the exam hall.
